

## Privacy Policy

Roodhals Capital is committed to preserving the privacy of all visitors to its website ("Website"). Please read the following privacy policy to understand how we use and protect the information that you provide to us.

**BY ACCESSING THIS WEBSITE, YOU CONSENT TO THE COLLECTION, USE AND TRANSFER OF YOUR INFORMATION UNDER THE TERMS OF THIS PRIVACY POLICY AND THE TERMS OF USE OF THIS WEBSITE.**

- 1. Controller:** The data controller who is responsible for the processing of personal data is Roodhals Capital B.V. ("Roodhals Capital"), with its registered office at Lange Voorhout 11 in The Hague, the Netherlands and listed in the Trade Register under number 34301643 at the Amsterdam Chamber of Commerce.
- 2. Information we collect from you:** when you visit our Website, you may be asked to provide certain information about yourself including your name and contact details. We may also collect information about your usage of this Website as well as information about you from e-mails, letters or any other correspondence between you and us.

Roodhals Capital does not undertake any obligations of non-disclosure or non-use of material received. Accordingly, please do not send any confidential or proprietary material to Roodhals Capital.

- 3. Use of your information:** Your information may be used for marketing and internal analysis purposes by Roodhals Capital and its directors and officers. We may also use and analyse the information we collect so that we can improve and develop our Website. In particular, we may use your information to contact you for your views on our Website and notify you occasionally about important changes or developments to the Website. Further, where you have consented, we might also use your information to let you know about products and services which we offer which may be of interest to you.
- 4. Disclosure of your information:** The information you provide to us may be accessed by or given to our staff working outside the Netherlands and the United Kingdom and third parties who act for us for the purposes set out in this policy and Terms of Use or for other purposes approved by you. Those parties process information and provide support services on our behalf. Otherwise, Roodhals Capital will not disclose your personal data to third parties, except where you have given your consent or where Roodhals Capital is under legal or regulatory obligation to do so.
- 5. Data outside the European Union:** In order to provide our services, it may be necessary for Roodhals Capital to transfer your personal data to a recipient in a country outside the European Union. In that case, Roodhals Capital ensures that such data transfer is in accordance with the regulation.
- 6. Cookies:** Roodhals Capital may use "cookies" to process and record information concerning your visit to and use of the Website and identify you when you visit the Website and to enhance your experience of the Website. "Cookies" are small pieces of information that your internet browser places on your computer's hard drive. "Cookies" may be used for remembering user names and preferences, tracking click streams and in the future for presenting users with personalised versions of the Website. You have the option of setting your browser to block "cookies". Please refer to the "help" function of your internet

browser for instructions. In some cases blocking “cookies” may reduce the functionality of the Website or prevent access to it depending on your chosen internet browser options.

- 7. Security and Data Retention:** To safeguard the confidentiality of your personal data and information contained in this Website, Roodhals Capital implements security measures in line with industry standard practices. The web servers are housed behind a secure firewall that prevents access to databases from unauthorised users. All of the servers are housed in a secure environment that is protected by physical security, with limited access to authorised staff only. We will retain your information for a reasonable period or as long as the law requires.
- 8. Links to other websites:** Our Website may contain links to other websites of interest. However, once you have used these links to leave our site, you should note that we do not have any control over that other website. Therefore, we cannot be responsible for the protection and privacy of any information which you provide whilst visiting such sites and such sites are not governed by this privacy statement. - 9. Your rights:** You have the right to request Roodhals Capital to give you access to your data. If the data are incorrect, incomplete or irrelevant, you have the right to ask us to alter or supplement them. You also have the right to object to the processing of these data and to ask Roodhals Capital to erase them.

Because the Employees of Roodhals Capital have an obligation to observe secrecy, it will not usually be possible to give you access to data that are processed in the context of providing our services. To the extent that our data processing is based on your consent, you at all times have the right to withdraw your consent. Withdrawal does not affect the lawfulness of the processing that was based on your consent before you withdrew it.
